

Subject:- Proceedings of meeting dated 7.11.13 held under the Chairpersonship of the Administrator(HQ), HUDA, Panchkula-CRM No M-26292 of 2013 Dharam Singh Yadav Vs State of Haryana- allotment of more than one plot under all the reserve categories including general category, fixed for 4.12.13.

The Chief Administrator, HUDA, Panchkula vide the order dated 19.10.2013 constituted a Committee of the following officers to cross check the lists of allottees who have obtained allotment of more than one plot under various reserved categories to be supplied by the Administrators/ Estate Officers:

2. First meeting of the above Committee has been held on 7.11.13. The General Manager, IT, HUDA, Panchkula supplied a category wise list of 1976 allottees detected by the system who have obtained allotment of more than one plot under various reserve categories i.e. 14 in number. Highest number of allotments are in Defence and GSRQ category i.e. 18770 and 12462 respectively and out of these, 556 and 330 (total 886) allottees have obtained double/ multiple allotments in defence and GSRQ categories respectively. The system has detected the cases having identical names and father's name.

3. After deliberating the matter for quite some time, following decisions have been taken by the Committee:

- (a) The General Manager, IT shall supply category wise list of such allottees by names, addresses and Urban Estate so that record may be verified by the concerned Estate Officers to find out the factual position by comparing photograph and all the relevant details of the allottees as per record.
- (b) The concerned Estate Officer shall supply the original record/ plot files of such allottees to the Head Quarter alongwith details on the prescribed proforma given below:

- (c) Two sub-committees one and two (as given below) shall be constituted of the following officers to scrutinize the record/ plot files of defence and GSRQ category respectively to verify the cases of double/ multiple allotments. The sub-committees shall submit their report to the Committee by the evening of 20.11.2013

- (d) A public notice of 30 days of second list of multiple plot allottees under defence and GSRQ category may be prepared to publish in newspapers within next 7 days directing the allottees to show cause as to why all the multiple allotments obtained by submitting false/misleading/incomplete affidavits be not cancelled. The public notice shall be as per proforma given below.

HARYANA URBAN DEVELOPMENT AUTHORITY

In compliance of the direction of the Hon'ble High Court in CRM No. M-26292 of 2013 titled as Dharam Singh Yadav Vs State of Haryana to ascertain the total number of allottees who have illegally obtained allotment of more than one plot under reserve categories, record of the various Urban Estates has been scrutinized and scrutiny revealed that the following allottees have obtained allotment of more than one plot under various reserve categories by submitting false/ misleading/incomplete affidavits. A list of all these allottees is given below.

2. *It has been the declared policy that an allottee under any reserve category is entitled to avail of the benefit of reservation only once in his/her lifetime in any of the Urban Estate.*

3. *A general notice is being hereby issued to all these below mentioned allottees to show cause within 30 days from publication of this notice as to why allotment of all the plots allotted to them under reserve categories be not cancelled for having been obtained fraudulently by submitting false/ misleading/incomplete affidavits. The reply along-with supporting documents, if any, may be submitted to the concerned Estate Officer.*

4. *The allottees under defence category are directed to submit an attested copy of the Adhar Card which is being provided free of cost by the Government of India. If Adhar Card not already made they may kindly do so immediately at the nearest UID Centre. The allottees under GSRQ are directed to submit their GPF/EPF number.*

5. IT SHALL BE THE LAST OPPORTUNITY AND IF THE ABOVE MENTIONED ALLOTTEES FAIL TO SUBMIT RESPONSE/ REPLY IN THE TIME GIVEN ABOVE, IT SHALL BE PRESUMED THAT THEY HAVE NOTHING TO SAY AND THE ALLOTMENT OF ALL THEIR PLOTS UNDER RESERVE CATEGORY SHALL BE CANCELLED AND CRIMINAL ACTION SHALL ALSO BE INITIATED AS PER LAW.

6. *This is the second list of the allottees who have been found to have obtained allotment of more than one plot under various reserve categories, so far,*

and scrutiny of other such allottees is being carried out which is likely to take some more time & will be published later on.

IMPORTANT:- If it is in the knowledge of anybody that a person has similarly obtained allotment of more than one plot under reserve category fraudulently by submitting false/ misleading/incomplete affidavit, he/she may intimate to the concerned Estate Office in this regard on their email address given below:-
