As per contents of the agenda item No.1 the issue was raised by one of the applicant to implement level of pay instead of basic pay in view of the floatation dated 13.04.2021. As per floatation only 4 applicants out of 7 applicants are eligible on the basis of level of pay.

# Progress of work of construction of HEWO flats at GH Site, Sec-19 & GH-20, Sec-21D, Faridabad.

Agenda item No.2 was discussed on 27.06.2023 as the contractor M/s Nanu Ram Goyal attended the meeting with a request to the Governing Body regarding progress of work of construction of HEWO flats at Faridabad and giving further extension to the Contractor M/s Nanu Ram Goyal & Co. Sh. Ashish Goyal, Contractor due to less supply of UPVC door and windows Finista make. He also appraised to the committee that despite depositing advance payment with Finista it could not provide the full supply due to their production constraints. Project Manager, HEWO, Faridabad also appraised to the committee that a meeting was also taken with the Finista representative at his level with other project stake holders wherein Finista has promised to supply all material by 30<sup>th</sup> September 2023.

After detail deliberations, it was decided to give extension of time period upto 15.09.2023 for which the pending works completion schedule shall be submitted by the contractor for strict compliance. Project Manager will clearly monitor the progress for timely completion. Failing which fine of Rs.10,000/- (Rs. Ten Thousand only) per day shall be levied after 15.09.2023 till completion of work besides penalty as per contractual agreement which is upto 10% of cost of tender document cost.

## Calculation of cost increase on account of additional FAR due to TOD policy availed of site GH Sector-19, GH-20, Sector-21D of HEWO scheme-II Faridabad.

After detail deliberations and keeping in view that TOD policy is applicable only in Sector-19, Faridabad as such it was decided that Additional FAR TOD policy cost for FAR 1.75 to 2.50 may be recovered from 321 flats of
